NE 119th Street Road Improvements

Mike Westerman, Purchasing Manager read a memo stating Purchasing and Public Works recommends that NE 119th Street Road Improvements be awarded to the low bidder, Rotschy Inc, of Vancouver, Washington, in the total bid amount of \$19,339,388.09 including Washington State Sales Tax, and grant authority to the County Administrator to sign all bid related contracts. The Board recognized the staff in their work and shared their excitement in participating in more projects.
