Harvest and Hauling of Timber from Auction Sales at South Hill

Mike Westerman, Purchasing Manager read a memo stating Purchasing and Environmental Services recommends that Harvest and Hauling of Timber from Auction Sales at South Hill be awarded to the low bidder, Rotschy Timber Management of Amboy, Washington, in the total bid amount of \$338,208.00 including Washington State Sales Tax, and grant authority to the County Administrator to sign all bid related contracts. 
