BUDGET IMPACT

The use of this service has been planned and budgeted as ongoing necessary work. No additional funds will be necessary from the General Fund or the Metropolitan Parks District maintenance fund to support this service.

ALTERNATIVES CONSIDERED

For years, Clark County Public Works has made use of private security services to open and close park gates and restrooms in parks that have no caretakers. This service has proven effective in the reduction of vandalism, unauthorized overnight camping, and the enforcement of park rules. Security services have also been employed on a day-by-day basis to protect assets from being defaced or destroyed while under construction and to secure special public event sites on an overnight basis. Without security in our parks, they are left vulnerable to crime and vandalism.
