

### ORDINANCE NO. M-4095

AN ORDINANCE fixing and levying the amount of ad valorem taxes necessary to balance estimated revenue with estimated expenditures for the 2015/2016 Budget for the City of Vancouver; providing for an effective date.

WHEREAS, the City Council finds that the total net amount of \$45,000,000 in revenue must be raised by ad valorem taxes on real and personal property within the corporate limits of the City of Vancouver to balance estimated revenues and expenditures for the 2015 budget for the City of Vancouver.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF VANCOUVER:

Section 1. There is hereby fixed to be raised by general property taxes upon real and personal property within the City of Vancouver the amount of \$45,000,000, for the following purposes:

# Ordinance / Resolution No. RCW 84.55.120

WHEREAS, the City Council of the City of Vancouver has met and considered (Governing body of the taxing district)
its budget for the calendar year 2015; and,
WHEREAS, the districts actual levy amount from the previous year was \$ 43,295,235.12 (Previous year's levy amount); and,
WHEREAS, the population of this district is more than or (Check one) less than 10,000; and now, therefore,
BE IT RESOLVED by the governing body of the taxing district that an increase in the regular property tax levy
is hereby authorized for the levy to be collected in the 2015 tax year.  (Year of collection)
The dollar amount of the increase over the actual levy amount from the previous year shall be \$ 432,952.35
which is a percentage increase of $\frac{1}{\text{(Percentage increase)}}\%$ from the previous year. This increase is exclusive of
additional revenue resulting from new construction, improvements to property, newly constructed wind turbines, any increase in the value of state assessed property, any annexations that have occurred and refunds made.
