

Ordinance / Resolution No. 2014-12-07 Ems 1

RCW 84.55.120

WHEREAS, the North Country EMS Dist #1 (Governing body of the taxing district) of Clark County (Name of the taxing district) has met and considered
its budget for the calendar year 2015; and,
WHEREAS, the districts actual levy amount from the previous year was \$ 536,341.78 (Previous year's levy amount); and,

BE IT RESOLVED by the governing body of the taxing district that an increase in the regular property tax levy
is hereby authorized for the levy to be collected in the $\frac{2015}{(Year of collection)}$ tax year.
The dollar amount of the increase over the actual levy amount from the previous year shall be \$ 68,155.39
which is a percentage increase of 12.70745 % from the previous year. This increase is exclusive of (Percentage increase)
additional revenue resulting from new construction, improvements to property, newly constructed wind turbines, any increase in the value of state assessed property, any annexations that have occurred and refunds made.
