- 2. Assess the costs and benefits of the Program




Job Creation – Fee Waiver Program

Value of Construction in Unincorporated Clark County: 2010 - 2014




Minimal Impact on Construction Activity


2011 Survey of Fee Waiver Recipients:

- 60% No impact on decision to build
- 16% Only accelerated plans to build
- 11% Not sure if they would have built
- 13% Would not have built without waiver



Majority of Fee Waivers Awarded to Industries That Would Have Grown Anyway







Estimated Fee Waivers Which Had no Impact on Business Growth or Job Creation

Low Range Estimate

\$4,688,244 60% of all fee waivers awarded

High Range Estimate

\$4,804,873 90% of all fee waivers awarded to retail, food,

entertainment, and consumer service industries

\$2,153,243 87% of fee waivers awarded to all other industries

\$6,958,116



Majority of Projects Receiving Fee Waivers Unlikely to Reduce Number of Residents Commuting to Oregon


- 55,000 Clark County residents commute to Oregon for work
- Over half earn \$769 per week or more

Program Funding May Not be Sustainable

Supporting the Program

- Costs paid for by construction in residential, government, etc.
- April, 2014 insufficient: (-\$350,000) for Building Fund
- Management projects continued trend

Traffic Impact Fees

- Could negatively impact competiveness for federal Grants
- May delay infrastructure projects



Best Practice and Other County Policies on Economic Development Programs

Missing Best Practices

- Clearly defining expected outcomes
- Automating / using data from state agencies

Other County Policies on Economic Development

- Increasing economic opportunity for all citizens
- Increasing standard of living through growth of family wage jobs; and
- Increasing the number of jobs available in Clark County to reduce the need for citizens to commute outside county



Results in Brief

Conclusions:

- 1. The Program, as it is currently designed, is not cost effective at achieving its intended outcomes
- The Program does not follow best practices or align well with other County policies on economic development



Recommendations

oud past, promising future

- 1. BOCC consider eliminating the Program, or work with DCD to implement substantial changes to improve its effectiveness.
- 2. If retained, align the Program with best practices and other County policies on economic development:
 - a. Clearly state expected outcomes of the Program and define performance measures;
 - b. Target higher paying family wage industries;
 - Implement procedures to track, monitor, and report total Programrelated construction;
 - d. Evaluate the economic and fiscal benefits of projects prior awarding sizable waivers;
 - e. Track fund balance by fund / department
 - f. Periodically poll fee waiver recipients to determine if subsidies influence behavior

Recommendations Continued

- g. Pursue data sharing agreements with the state to verify jobs;
- h. Establish net new job creation and retention requirements;
- i. Establish enforcement mechanisms i.e., "clawback" provisions;
- j. Establish expiration date system for waivers; and
- k. Survey the business community at large to evaluate their perception of Clark County as a business friendly location.
