BACKGROUND

The nature of the work performed by the Office Assistant's (OA's) in the Assessor's Office is complex and requires a strong analytical ability, however it also requires a learning curve for the individual to become proficient with the RCWs and WACs that govern the programs we administer and manage. Converting the existing OA II (AGS0060) from an OA II to an alternatively staffed OA III, would create greater flexibility within the Office to meet the taxpayer's needs while continuing to meet our statutory obligations. The Assessor's Office moved to convert existing OA positions to alternatively staffed OA II/III roles in 2012. Making this change would bring this position in line with the existing staffing model. Further, the use of alternatively staffed roles enables the Office to hire the right candidates at the right level based on their knowledge, skills and experience and to promote staff only when they have achieved the level of proficiency required to perform work at the higher level within the classification.

Human Resources has reviewed and supports this request.


These changes result in a savings of \$250 for the 2013/2014 biennium and a savings of \$1,508 for the 2015/2016 biennium.
