**BACKGROUND**: Clark County entered into an Interlocal Agreement with the Port of Vancouver on September 30, 2014 to establish the basis of cooperation for the purposes of planning and execution of projects for industrial development, job creation and economic development purposes of mutual interest. Establishing a supply of development-ready large sites with rail service has been identified as a critical regional need to attract and retain large industrial firms and generate traded-sector jobs.

The industrial land site readiness project is a joint effort by Clark County and the Port of Vancouver through the Interlocal Agreement relationship to address the need for industrial employment land in Clark County served by freight rail and truck infrastructure. The project will evaluate sites in the St. Johns/Barberton area as to market readiness with respect to regional economic development goals and target industries, clearly identifying opportunities and constraints for involved stakeholders.

Mackenzie, a contractor with experience and established credentials in conducting this type of analysis within the region, was competitively selected using the MRSC roster.

**BUDGET AND POLICY IMPLICATIONS:** The industrial land site readiness project is funded through \$70,000.00 of general fund and a contribution from the Port of Vancouver in the amount of \$32,100.00 through the Interlocal Agreement.

# ADDENDUM No. 1 TO INTERLOCAL AGREEMENT BETWEEN CLARK COUNTY, WASHINGTON AND PORT OF VANCOUVER, WASHINGTON

THIS ADDENDUM No. 1, hereinafter referred to as the "ADDENDUM", to the INTERLOCAL AGREEMENT between the PORT OF VANCOUVER, hereinafter referred to as the "PORT", and CLARK COUNTY, hereinafter referred to as the "COUNTY", is entered into to execute a project, hereinafter referred to as the "PROJECT", as provided for under Section 3 of the INTERLOCAL AGREEMENT.

# NOW THEREFORE the COUNTY and the PORT agree:

# SECTION 1: PURPOSE, SCOPE, and DELIVERABLES

The purpose of the PROJECT is to contract with a consultant to conduct a study entitled the "Clark County Industrial Land Site Readiness Project". The PROJECT is an effort to address the need for industrial employment land in Clark County served by freight rail and truck infrastructure. The PROJECT will evaluate sites in the St. Johns/Barberton area of Clark County as to market readiness with respect to regional economic development goals such as recruitment and retention of targeted industry clusters, clearly identifying opportunities and constraints for involved stakeholders. Deliverables include reports, data and analysis, as well as presentations of the same to COUNTY and PORT executives, officers, stakeholders and other leadership as appropriate.

The consultant's detailed scope of work is attached as EXHIBIT A to this ADDENDUM. PROJECT completion is expected by June 15, 2015.

### SECTION 2: LEAD PARTY

COUNTY shall serve as the leading party for the PROJECT. COUNTY will select a qualified consultant through a competitive process using the MRSC roster and enter into a personal services contract with the consultant. PROJECT deliverables shall be jointly owned by COUNTY and PORT. COUNTY agrees to provide \$70,000.00 in funding for the PROJECT upon the effective date of this ADDENDUM. PORT agrees to provide \$32,100.00 in funding for the PROJECT for which COUNTY will provide a lump-sum invoice in January, 2015.
