

SUBJECT: Award of CRP #333522 Sara Junction Slope Stabilization - Phase 2

The Sara Junction Slope Stabilization - Phase 2 project will stabilize a failing roadway slope and protect the embankment from further stream migration. It will also patch deterioration of an existing concrete culvert.

Correcting a scrivener's error in the earlier resolution, it will be necessary for the safety of workers and the public to close <u>all</u> lanes of NW 41st Avenue to through traffic for the duration of the project, expected to take approximately 80 days. Public notice and detour information will be provided."

Purchasing received seven responses to CRP #333522. The bids were checked for accuracy, content, and compliance to specifications.

Purchasing and Public Works recommend that Sara Junction Slope Stabilization Phase 2, be awarded to the low bidder Keystone Contracting, Inc. of Ridgefield, WA, in the total bid amount of \$436,500.00 including Washington State Sales Tax, and grant authority to the County Manager to sign all bid related contracts.

Seven (7) firms submitted bids in the amounts shown on the attached Tabulation of Bids and Bidders. The low bid of \$436,500.00 was submitted by Keystone Contracting of Ridgefield, Washington.

We recommend that the Board of County Councilors award the contract for the construction of Sara Junction Slope Stabilization - Phase 2 NW 41st Avenue, south of NW 179th Street, CRP#333522, to Keystone Contracting in the amount of \$436,500.00.
