BID NAME

Bid #2615 - Track Rehabilitation – Mile Post 0.14 – 14.50

BID DESCRIPTION

Railroad track and structure rehabilitation work at various locations on the Chelatchie Prairie Railroad including:

1. Approximately 1,100 feet of track between mile post 0.14 and 1.0
2. Approximately 300 feet of track at the Highway 99 overcrossing (mile post 1.68)
3. Replacement of two track turnouts in the Rye Yard between mile post 3.43 and 3.45
4. Reframing one bridge bent and replacement of several bridge stringers at the Salmon Creek overcrossing known as Bridge 12 located at mile post 12.45
5. Track realignment and rehabilitation in the Battle Ground Yard and reconstruction of the East Main Street grade crossing located between mile posts 13.8 and 14.3

SOURCE OF FUNDS

1. WSDOT Freight Rail Assistance Program (FRAP) grant \$636,546.16
2. WUTC Grade Crossing Protective Fund (GCPF) grant \$20,000.00

BUDGET IMPACT

Grant-funded; no additional budget required

ALTERNATIVES CONSIDERED

No-build alternative results in greater risk and expense to county. Project is part of on-going railroad rehabilitation program.

This contract will provide for railroad track and structure rehabilitation work at various locations on the Chelatchie Prairie Railroad

Purchasing received a sole response to Bid #2615. The bid was checked for accuracy, content, and compliance to specifications.

Invitations to bid were sent to sixty-four vendors of whom one response was received. The Director of Economic Development reviewed the response and determined it to be in compliance to specification and within the departments' original estimate, which was developed through market research and previous bids. Purchasing feels there is sufficient information to insure competitive pricing.

Purchasing and the Director of Economic Development recommend that Bid #2615, be awarded to the sole bidder, West Rail Construction Company LLC of Vancouver, WA in the total bid amount of \$595,793.50 including Washington State Sales Tax, and grant authority to the County Manager to sign all bid related contracts.
