#### FINAL ORDER OF VACATION

In the matter of the Petition of Kess Romano for the partial Vacation of a County Road known as a portion of NE 13<sup>th</sup> Avenue in the SW 1/4 of Section 2, Township 2 North, Range 1 East, W.M., Clark County, Washington.

The **BOARD** having on the 24<sup>th</sup> day of March, 2015, ordered the vacation of said road upon payment by the principal petitioner of all costs and expenses incurred in the proceedings, and said costs and expenses amounting to the sum of Six Thousand Five Hundred Ninety-Six Dollars and 15/100 (\$6,596.15), having been paid to the Treasurer of this County on the 16<sup>th</sup> day of April, 2015, and all conditions being met.

IT IS ORDERED BY THE BOARD, all members concurring, that the County Road petitioned to be vacated by Kess Romano, be vacated as follows:

#### Legal Description

A 10 foot wide strip of land located in the Southwest Quarter of Section 2, Range 1 East, of the W.M. lying Clark County Washington described as follows:

Commencing at the Southwest corner of said Southwest Quarter of Section 2; Thence, South 89°07'49" East along the South line of said Southwest Quarter of Section 2, a distance of 738.10; Thence, North 00°52'11" East 1218.86 feet to a point in the centerline of NE 13th Avenue which is the Southwest corner of that tract conveyed by deed to Clark County recorded under Auditor's File No. G517114, records of Clark County; Thence, South 88°15'09" East along the South line of said tract 30 feet to the TRUE POINT OF BEGINNING; Thence, North 01°44'51" East parallel with the centerline of said NE 13th Avenue 132 feet to the North line of said Clark County tract; Thence, South 88°15' 09" East along said North line 10 feet to the Northwest corner of that tract conveyed by deed to Todd Francis recorded under Auditor's File No. 9306210310 records of Clark County; Thence, South 01°44'51" West along the West line of said tract 132.00 feet to the Southwest corner of said tract, said point being on the South line of said Clark County tract; Thence, North 88°15'09" West along the South line of said Clark County tract 10 feet to the TRUE POINT OF BEGINNNING.




