Approve closure of the Clark Vancouver Regional Drug Task Force Vehicle Buy Fund.

BACKGROUND

In 1998, the BOCC approved staff report 3-24-98 SR 93-98, which authorized the creation of a revolving checking account in the amount of \$14,000 for Clark-Skamania Drug Task Force (now the Clark Vancouver Regional Drug Task Force) vehicle acquisitions. Due to operational changes, the Vehicle Buy Fund is no longer used and no longer needed.

The Clark Vancouver Regional Drug Task Force Executive Board approved the closure of the Vehicle Buy Fund on March 27, 2015. To complete the closure process, it is also necessary to receive authorization from the BOCC.

SPECIFIC REQUEST: Authorize and approve a revolving checking

account for CSDTF car acquisitions.

Background: The executive board of the CSDTF, approved the creation a "car fund" for the purpose of confidential, quick purchase of undercover vehicles by CSDTF via trade-in plus cash or outright purchase. Consistent with Auditors Office instructions and curent audit recommendations:

- * Existing funds in the amount of \$14,188.75 was deposited within County Treasury, on 11-10-97, receipt # 88610, to create the revolving fund.
- * This staff report is remitted to a) authorizes a CSDTF revolving fund and b) directs the Treasurer Office to establish the fund checking account.

The limitations and funding of the revolving checking account are set forth below, as advised by the Auditors Office. Further, all reimbursements to the revolving fund, would be from existing CSDTF expense budgets with no impact to any other county fund.

Budget Implications: No change to CSDTF budget. All funding for the revolving fund provided by CSDTF. Car purchases limited to \$5,000 each. The initial revolving fund checking account fund balance is set at \$14,000.

Policy Implications: None. No change to county policy.

Action Requested: That the Board approve the requested revolving checking account and directs the Treasurers Office to:

** Open a business checking account, with a certified banking institution, for the CSDTF with an initial fund balance of \$14,000 to be managed at CSDTF.
