**DEPARTMENT/DIVISION: FAIR** DATE: May 28, 2015 **REQUEST:** Approval for Capital Project **CHECK ONE:** Consent County Administrator BACKGROUND: The contract for Carnival Services at the Clark County Fair by Butler Amusements contains a provision whereby Butler contributes an amount of \$25,000 per year for Capital Improvement projects that are for the benefit of Butler during the Fair and the Event Center the rest of the year. The current request by Butler is for a power distribution system in the carnival village that would eliminate the need for them to run portable generators 24 hours per day from approximately one week prior to the Fair until the day after the Fair. That cost of the project, which is a combination of County and Clark PUD resources is just below \$50,000. As a result, there was not a project accomplished last year but those funds were saved and combined with this years funds to cover the cost of this project. **COMMUNITY OUTREACH:** The project will eliminate the noise complaints we receive each year from the neighboring residences that are subjected to the generator noise and save fuel and improve the air quality in the campground and the surround neighborhoods. BUDGET AND POLICY IMPLICATIONS: None.
