## BACKGROUND

The Board of County Commissioners adopted the 2015 Annual Construction Program (ACP) on November 18, 2014, in compliance with RCW 36.81.121. This is a request for a hearing to amend the 2015 ACP to comply with specific legal and grant funding requirements. The ACP must be amended through a legal adoption process (WAC 136-16-042). The approximate difference between the 2015 Adopted ACP (\$39M) vs the Amended ACP (\$38M) is \$1 million.

A hearing for the Board's consideration and adoption of the amended 2015 ACP is scheduled for 10:00 A.M. on Tuesday, November 10, 2015.

## COUNCIL POLICY IMPLICATIONS

None. Per WAC 136-16-042, the ACP must be amended through a legal adoption process.

## ADMINISTRATIVE POLICY IMPLICATIONS

None. The 2015 ACP is constrained by County Road Fund revenues. There are no policy implications resulting from this request.

## COMMUNITY OUTREACH

The development of the 2015 ACP included press releases, internet web sites, and a SEPA environmental review process. The Public Hearing before the Board of County Councilors is the final installment in the public involvement process.
