The Board convened in Conference Room 698, 6th Floor, Public Service Center, 1300 Franklin Street, Vancouver, Washington. Chair Marc Boldt, Councilor Jeanne E. Stewart, Councilor Julie Olson, Councilor David Madore and Councilor Tom Mielke present.

**Approval of minutes for September 7 and September 14, 2016**

**ACTION:** Moved by Olson to **APPROVE** the minutes for September 7, 2016 and September 14, 2016. Stewart seconded the motion. Chair Marc Boldt, Councilors Stewart, Olson, Madore, and Mielke voted aye. Motion carried.

**Councilor Madore's information request**

Chris Horne, Prosecuting Attorney's office, presented. He referenced an email between the County Manager, Mark McCauley, and Councilor David Madore. He also spoke about the Charter guidelines. He inquired about the Board's position and inquired on how to move forward. Boldt inquired about the difference between a public records request versus an individual Councilor request. Horne responded. He spoke about staff time that would be needed to meet the request. Stewart inquired about the information that would need to be redacted. Horne responded. Further discussion ensued. Further discussion ensued about the scope of the request. Madore spoke about the accountability of the County Manager. Olson spoke about narrowing down the request and stated her concerns with Madore's recent newspaper and confidential documents he receives as a Councilor. Madore responded. Mielke spoke further about Madore's request. Horne clarified the difference of the reports. Olson and Stewart stated their concerns / conflicts with Madore's request. Horne spoke further about processing public records request. Bob Stevens, Deputy County Manager, joined the discussion. Horne spoke further about the Charter guidelines. Further discussion ensued about the request.

**ACTION:** Moved by Madore to respect the requested information within the limits of the law. Mielke seconded the motion.

Olson inquired about secret contracts. Mielke spoke about an investigation regarding himself and Madore. Further discussion ensued about legal contacts. Boldt stated he thinks Madore should follow his request though a public records request.

Councilor Madore and Mielke voted aye. Chair Marc Boldt, Councilors Stewart and Olson voted nay. Motion failed.

Councilor Stewart and Olson stated Madore is able to get all of his information through a public records request.






