

The grant is for a three-year period for \$150,000.

### PUBLIC HEARING: CLARK COUNTY STORMWATER MANUAL MINOR UPDATE

To consider proposed minor updates to the Clark County Stormwater Manual 2015 (Manual). Pursuant to Clark County's Phase I Municipal Stormwater Permit issued under the National Pollution Discharge Elimination System (NPDES) program, the county updated the Manual and code to be equivalent to the 2014 Stormwater Management Manual for Western Washington. The County Manual was adopted by reference in the updated stormwater code. Proposed minor manual changes include errata to correct formatting and scrivener's errors and several minor corrections to include omitted or incorrect text discovered in the 2015 manual.
