24	The Board hereby adopts the findings and conclusions contained in the recital clauses above as
25	findings supporting this resolution. The Board, within the limits of the law, adopts as policy, the
26	commitment to continually seek for ways to ease the burden, lower the cost, simplify the process,
27	and as a rule, to diligently work to avoid going above and beyond state and federal standards where
28	possible.

30	This policy would equally apply to evaluating and amending existing county plans and codes as well
31	as new county plans and codes proposed for adoption. This policy would compel the evaluation of
32	the code section under consideration for compliance with this policy.
