against the County in the amount of \$3,084,729.91.

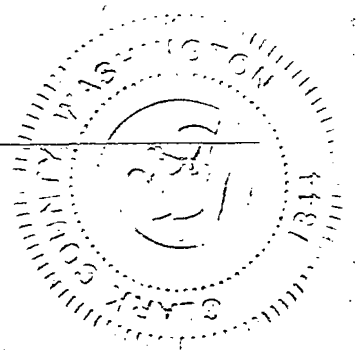
