BACKGROUND:

Approximately 15 December 2015, a section of the Clark County-Chelatchie Prairie Railroad (CCCP) was undermined due to an extensive culvert washout. The location of the washout was mile post 24 by the tunnel entrance. The culvert washout, which was 40-50 feet deep, undermined 50 linear feet of the rail line which if not immediately repaired would have continued to widen the washout, (especially during the winter months), resulting in more costly repairs and down-time for the railroad. Until repaired, all rail traffic in this vicinity is stopped and the downhill park area is threatened.

This section of the CCCP rail line is critical for rail operations and the ability of the railroad operator to transport goods pursuant to client agreements and contracts. It is Clark County's responsibility to maintain the rail line in a safe and operable condition with regard to threats away from or on the line.

Three vendors were immediately contacted to determine if they were available to make repairs within 24 hours; Belfour Beatty, Railworks, and West Rail Construction Company. Due to the emergent conditions in this incident, the normal bid process for repairs could not implemented. West Rail Construction Company of Vancouver, WA was the only company available to conduct the work and their services were procured. West Rail Construction immediately initiated repairs to the rail line. Costs for the repairs are \$29,247.13.

COMMUNITY OUTREACH: Not Applicable

BUDGET AND POLICY IMPLICATIONS:

Cost for repairs will be paid from the County's liability fund. It is designed and budgeted for this. Cost is less than the \$50,000 deductible and will not be submitted to the insurer.

Per Clark County Purchasing Policy P-220 – Emergency Purchases Policy – "In an event of an emergency when the public interest or property of the County would suffer material injury or damage by delay, all competitive processes including formal bidding may be waived." Further, pursuant to RCW 36.32.270 and RCW 39.04.280, for purchases exceeding \$25,000.00, the Clark County Board of County Counselors grants authority to the County Manager to declare an emergency and waive the bidding requirements in conformance with the statutes in the event that the County Manager, after extensive attempts, is unable to confer with the members of the of the Board of County Counselors in making such a declaration. In addition to the power to declare a county emergency, the County Manager shall have the authority to waive the bid requirements as outlined by the statute in order to remove immediate threats and prevent further loss to the health, safety, property and welfare of the citizens of Clark County. Any actions that go beyond removal of immediate threat, needs the approval of at least three members of the Board of County Counsel of County.

A brief, concise report regarding the factual circumstances of the emergency along with any and all contracts entered into the emergency authority, shall be presented to the Board of County Counselors for ratification within two (2) weeks of the signing of the contract by the parties for entry in to the official record







RESOLUTION NO. 2014-02-01

A RESOLUTION relating to the waiver of bid requirements and retroactively approving the repair of a culvert washout that undermined 40-50 linear feet of Clark County Chelatchie Prairie Rail Line which terminated commerce on the railroad and if not immediately repaired would have resulted in additional damage and material loss to the rail line.

WHEREAS, RCW 36.32.270 allows the County legislative authority to waive the competitive bid requirements, pursuant to RCW 39.04.280, as an emergency exists based upon unforeseen circumstances beyond the control of the municipality that will likely result in a material injury, bodily injury, and additional damage if delayed; and

WHEREAS, a culvert washout discovered on December 15, 2015, measuring 40-50 inches deep by 40-50 feet wide, effectively terminated use of the Clark County Chelatchie Prairie Railroad by the railroad operator in the area of MP 24. If not immediately repaired, the washout most probably would have increased in size, thereby increasing the cost of repair to the County and further delaying return of rail service and transfer of goods; and

WHEREAS, three railroad construction companies were contacted by the County to determine their availability to repair the washout, only one of the companies could immediately initiate the needed repairs; and

WHEREAS, due to the potential for additional harm and bodily risk, the County approved contracts for the repairs; and

WHEREAS, it has been brought to the attention of the Board of County Councilors of Clark County, Washington, that findings and conclusions are required to support the waiver of bids and the immediate approval of repairs, now, therefore,

BE IT ORDERED AND RESOLVED BY THE BOARD OF THE COUNCILORS FOR CLARK COUNTY, STATE OF WASHINGTON that the purchasing and posting requirements of RCW 36.32.245 are hereby waived pursuant to RCW 32.32.270 and RCW 39.04.280 and emergency repairs are authorized. Copies of this resolution shall be filed with the Clark County Auditor.
