BACKGROUND

The NE 58th Street Sidewalk project will construct approximately 0.40 miles (2,200 feet) of sidewalk along one side of NE 58th Street between NE 59th Avenue and NE Andresen Road. The project will provide a continuous walkway connection to Andresen Road for residents along NE 58th Street, as well as neighbors north and south of NE 58th Street.

For the safety of workers and the traveling public, Clark County may temporarily close portions of one travel lane to through traffic during construction.

None. This project is included in the 2016-2021 Transportation Improvement Program (TIP), 2016 Annual Construction Program (ACP #20) and 2015/2016 Biennium Budget.

NOTICE TO CONTRACTORS

NOTICE IS HEREBY GIVEN that sealed bids will be received until **1:50 P.M. on Tuesday, April 12, 2016**, by the Clark County Board of County Councilors through the General Services Purchasing Department, 1300 Franklin Street, Suite 650, Vancouver, Washington 98660, for the **NE 58th Street Sidewalk, CRP No. 352622**; and other work; then publicly opened and read aloud at the Commissioners' Hearing Room, 6th Floor of the Public Service Center, 1300 Franklin Street, Vancouver, Washington 98660, at 2:00 P.M. on **Tuesday, April 12, 2016**, or as soon thereafter as the matter may be heard.

Description of work: The project proposes to construct approximately 3,100 feet of walkway along alternate one side of NE 58th Street from NE 59th Avenue to NE Andresen Road. The walkway will start on the south side of NE 58th Street at NE 59th Avenue. It will cross to the north side at NE 66th Ave and continue on the north side to NE Andresen Road. The walkway will be constructed as a separated walkway with both curb and no curb. Underground rock trenches and perforated pipes will be placed under the new sidewalk for drainage purposes.

Primary bid items: Roadway Excavation (Incl. Haul); Crushed Surfacing Base Course; HMA Cl. Concrete; Pervious Cement Concrete Sidewalk; Storm Sewer Pipe; Manholes; Conc. Traffic Curb And Gutter; Traffic Signal; Traffic Control; Block Retaining Wall; Striping.

This service is provided free of charge to Prime Bidders, Subcontractors, and Vendors bidding on this project. Bidders are encouraged to "Register as a Bidder" in order to receive automatic email notification of future addenda and to be placed on the Bidders List.

Answers to bid questions will be posted on the project's "Bid Inquiry Log", also located on the County's Internet page, which will be updated twice daily, at noon and 6:00 PM. The questions and answers posted on the Bid Inquiry Log will not identify who asked the question, nor will that information be provided otherwise. It is considered exempt from Freedom of Information requirements. The last Bid Inquiry log update prior to bid opening will be 6:00 PM the day before the bid opening, and will display all questions and answers to the questions that have accumulated by the posting time. Questions asked after this time will not be addressed. Questions too late to be answered as of that posting will remain unanswered and will not be included in the log.

All bids shall be delivered to the attention of the Clark County Purchasing, P.O. Box 5000, Vancouver, Washington 98666-5000 or 1300 Franklin Street, Suite 650. Bids shall be placed in a sealed envelope, marked "Sealed Bid", which clearly states the name of the bidder, the project number, the project title, the date of the bid opening, and appropriate wording to indicate definitely the nature of the contents. Do not send bids by FAX or email. Bids submitted by FAX or email will not be accepted.

A bid proposal deposit, made in the form of a certified check, cashier's check, or surety bond in an amount equal to five percent (5%) of the amount of the bid proposal, shall accompany all bid proposals. Should the successful bidder fail to enter into such contract and furnish satisfactory performance bond within the time stated in the specifications, the bid proposal deposit shall be forfeited to the Clark County Road Fund.

The right is reserved by the Clark County Board of County Councilors to waive informalities in the bidding, accept a proposal of the lowest responsible bidder, reject any or all bids, republish the call for bids, revise or cancel the work, or require the work to be done in another way if the best interest of the Contracting Agency is served.

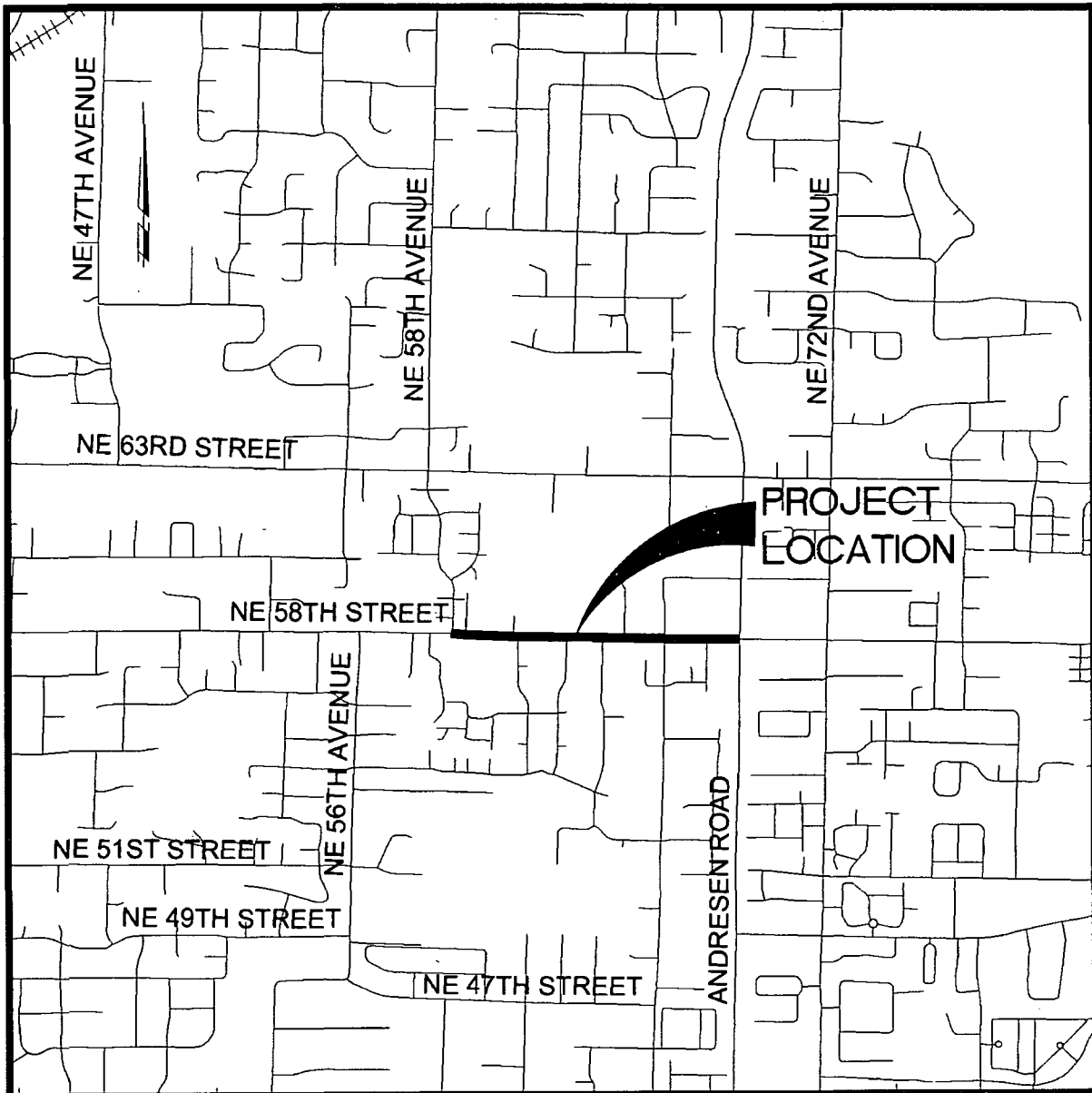
