REQUESTED ACTION:

Authorize the County Manager to sign the Change Order Agreement with Executive Information Services, Inc. (EIS) for the procurement, licensing, and maintenance of a Criminal Records Management System.

BACKGROUND

The County Sheriff and Chief Information Officer (CIO) have a shared desire to acquire a Records Management System (RMS) that fully integrates with the existing Jail Management System (JMS) and meets the operational needs and requirements of the Sheriff's Office, the Prosecutor's Office and the Courts. For the last several months, the Sheriff's Office and other stakeholders have been evaluating RMS system options, including the RMS module offered by EIS.

On February 23, 2016, the County Council approved Resolution #2016-02-12, which authorized the initiation of contract negotiations with EIS to acquire the RMS that fully integrates with the vendor's JMS. Following six weeks of intensive scoping, plan development, and negotiation with EIS, the Sheriff and the CIO have developed the attached Change Order Agreement that, if approved, will complete this process to enable the procurement, licensing, and maintenance of the vendor's RMS.

Highlights of the Change Order Agreement include:

- Accelerated implementation to meet year-end deadline
- One-time implementation costs that are within remaining project budget
- Ongoing system costs 40% below RegJIN subscription costs; fixed for five years
- Scalable roll-out plan enables interested City PDs to join the system now or in the future

The Sheriff Office, with substantial input from other County L&J departments and City PDs, has determined that the EIS Records Management System provides the necessary functionality, integration and usability to meet our collective needs. The Sheriff and CIO recommend approval of the Change Order Agreement.

6. Installation includes application software installation on user supplied computing platform, all table configuration, end-user training, network configuration, and similar activity. Installation also includes general network design consulting, network configuration, and installation and/or configuration of operating system software; including the Windows operating system and Microsoft SQL Server database management system. Agency is responsible for insuring that personnel are available and free of regular duty assignments during scheduled training periods. Training will require approximately 8 hours per person.
