BACKGROUND

Clark Regional Wastewater District is replacing sewer pipes and laterals along the east side of Highway 99 from NE 63rd Street to NE 78th Street and one crossing of Highway 99 at Repass Road. As such, traffic will be shifted west between the intersections to allow room for crews to work. A reduced speed limit in the construction zone will help provide a safer working environment for the contractors, as well as the traveling public.

RESOLUTION NO. 2016-04-10

A **RESOLUTION** to install a temporary 25 MPH zone on Highway 99 from NE 63rd Street to NE 78th Street for the duration of the Clark Regional Wastewater District sewer replacement project.

WHEREAS, the Board of County Commissioners has legislative jurisdiction over specific traffic operations, including designating roadway or specific lanes which vehicular traffic can and cannot proceed; and

WHEREAS, establishment of the attached traffic control is deemed advisable and in the best interest and safety of the traveling public; and

WHEREAS, the Board of County Commissioners has determined that adoption of this resolution for a temporary speed zone provides a general public benefit and will sunset upon completion of the Clark Regional Wastewater District sewer replacement project but no later than the sunset date, now therefore,

IT IS HEREBY ORDERED AND RESOLVED by the County Council of Clark County, State of Washington, that the following road be established with the following speed limits temporarily:

<u>A speed of 25 MPH</u> on Highway 99 from NE 63rd Street to NE 78th Street. The modified speed limit will be in effect until the end of road construction but no later than November 30, 2016.

THE WASHINGTON STATE PATROL is requested to enforce the provisions of this resolution

THE SHERIFF OF CLARK COUNTY is directed to enforce the provisions of this resolution.

THE DIRECTOR OF PUBLIC WORKS is directed to erect and maintain the necessary signs in accordance with the Uniform Standards adopted by the Washington State Secretary of Transportation at both ends of Highway 99 with the modified speed limit.
