Board of County Councilors approval for a one-time transfer from the Mental Health Sales Tax fund (fund 1033) to the Clark County Public Health fund (fund 1025) in an amount not to exceed \$1,100,000 to fund the Nurse-Family Partnership Program within Clark County Public Health.

BACKGROUND

The Nurse-Family Partnership (NFP) program is a nationally-recognized evidence-based nurse home-visiting program serving low-income, first-time, high-risk mothers from early pregnancy through their child's second birthday. NFP is recognized as a key program for the reduction of Adverse Childhood Experiences (ACEs) through providing support and education focused on improving child health and development, and helping parents provide sensitive and competent care.

Clark County chose to implement NFP in 2007 because of the NFP model's strong track record in:

- overcoming health and educational disparities
- reducing and preventing:
 - o substance abuse
 - o child abuse, neglect, domestic violence and injuries
 - o juvenile delinquency
 - o alcohol and other drug use in adolescents whose families received NFP services

The goals of NFP are to:

- Improve pregnancy outcomes by helping women engage in good preventive health practices
 that include ensuring thorough prenatal care from their healthcare providers, improving
 their diets, and reducing their use of cigarettes, alcohol and other substances
- Improve child health and emotional development by helping parents provide responsible and competent care
- Help parents develop a vision for their future, continue their education, find work, and become economically self-sufficient

Many participants of the Nurse Family Partnership program are at risk of chemical dependency or mental health issues and are referred to treatment.

Clark County has invested in specialized NFP training for public health nurses (PHNs) and their manager to meet the requirements of the NFP model. The PHNs are trusted professionals who form a strong partnership with their clients, helping clients break down barriers in order to achieve financial independence and reach their life goals. CCPH's NFP program has enrolled 462 first-time moms, providing the opportunity to transform their lives and those of their children.



NFP delivers multi-generational outcomes that prevent substance abuse, address and prevent mental health issues in the mother and child and reduce the costs of long-term social service programs Research by the RAND Corporation estimates NFP returns up to \$5.70 for each \$1 spent on the program.

Clark County Public Health is facing a 2017-18 budget deficit of approximately \$1.5M. While the Nurse-Family Partnership is a tremendous asset to the community, without the funding requested in this staff report, Clark County Public Health will have no choice but to propose elimination of the program. Clark County Public Health management and staff have been working with a coalition of community partners to arrive at a collaborative community-based funding strategy to sustain the NFP program, beginning no later than January 1, 2018. One-time funding from the Mental Health Sales Tax Fund (fund 1033) will allow NFP to continue to function while that funding strategy is negotiated.

COMMUNITY OUTREACH

Nurse-Family Partnership (NFP) is well integrated in the community. For example, NFP program staff collaborates with the school districts' teen parent programs to ensure pregnant and parenting teens graduate. Referrals to NFP come from a wide variety of sources including prenatal care providers, Medicaid Managed care plans, juvenile justice, school nurses, GRAD Teen Parent program, and the Women, Infants and Children's nutrition program (WIC).
