### **Executive Summary**

Two new commissioners were appointed in 2016 to the Clean Water Commission (CWC). The Commission met a total of six regularly scheduled meetings. Six Commissioners also attended an educational tour of stormwater facilities in October.

The Department of Environmental Sciences (DES) was dissolved in June and the Clean Water Division was assigned to the Department of Public Works, where it was located prior to the formation of DES. Andrea Logue was selected as the new Clark County Staff Liaison.

The CWC area of focus in 2016 was educating the commission to provide public outreach. The Communication team gave two presentations to community organizations.

This annual report details scheduled meeting topics, staff reports, accomplishments, recommendations, and the action plan for the upcoming year. The CWC will continue to advise the Clean Water Division, County Manager and County Councilors with regard to current stormwater issues.

## Meetings

The CWC meeting schedule of every other month begins in January and ends in November. The CWC also attended a stormwater facilities tour to better understand the various methods of storm systems. Overall the meeting attendance was excellent with only a few of the Commissioners having conflicts. One member decided not to renew his term, and another resigned after the November meeting.

## Challenges

- 1. Changing membership of the CWC presents an opportunity and a challenge. We can improve the speed at which new members are effective by establishing an on-boarding process for new members to the CWC.
- 2. Discontinuity of committee meetings limited working group effectiveness.

### Recommendations

- 1. We recommend that any fee increases and/or new fees are fully vetted and understood by the Clean Water Commission prior to facilitating public outreach and support of the fees.
- 2. We recommend that the commission provide input for the 2017-18 biennium budget.

## 2017 Work Plan

- 1. Continue with three working groups in the CWC. Utilize Project Sub-Teams targeted at working group objectives. Opportunity to improve group effectiveness by using conference calls to maintain progress between CWC meetings.
  - a. Communication Team: Provide input on the public outreach presentations and continue to be a positive presence in the community.
  - b. Partnership Team: Collaborate with other advisory groups to establish amenities such as trails and educational opportunities on stormwater facility sites.
  - c. Research Team: Responsible for defining and gathering data and information needed by the CWC members to evaluate programs and make recommendations.
- 2. We will continue to review the Clean Water Budget in 2017 and provide feedback and recommendations per our charter.
- 3. Formalize new CWC member selection process with CWC leadership, or designee, participation in the decision-making process.
- 4. Opportunity to improve and codify on-boarding process for new members to the CWC.
- 5. Modify bylaws to reflect member participation rate requirements.

### Summary

In conclusion, the CWC is actively involved in working with the Clean Water Division and the Board of County Councilors to advise on the current stormwater issues facing the county. The CWC also plays a role on providing educational outreach within the community. In moving forward, the CWC respectfully asks the Board of Clark County Councilors to offer input as to what they foresee as the critical issues that should be addressed in the upcoming year.
