**PUBLIC HEARING: 2017 SUPPLEMENTAL APPROPRIATION**

To consider the 2017 supplemental amending the 2017-2018 biennial budget in the following amounts:

A total increase in expenditures of \$53,640,395; total revenue changes total \$15,055,296; resulting in a combined net decrease in fund balance of \$38,585,099.

Adriana Prata, Budget Director presented. Further discussion ensued. Bob Stevens, Deputy County Manager joined the discussion.

**PUBLIC COMMENT REGARDING PUBLIC HEARING: 2017 SUPPLEMENTAL APPROPRIATION**

**ACTION:** Moved by Stewart to **AMEND** Resolution 2017-05-11 to appropriate \$203,745 in General Fund expenditures in order to add two new ongoing positions, a Support Supervisor and a Support Specialist, to the Public Disclosure Unit to address ongoing public records requests; and appropriate \$100,000 one-time General Fund expenditures to complete a study of the staffing needs in the Sheriff's records unit. Blom seconded the motion. Chair Marc Boldt and Councilors Stewart, Olson, and Blom voted aye. Motion carried.

**ACTION:** Moved by Boldt to **AMEND** Resolution 2017-05-11 to appropriate \$275,000 one-time Real Estate Excise Tax Fund 3083 expenditures to provide funding for planning and completing replacement of the existing agricultural irrigation system at Heritage Farm. The existing irrigation system responsible for supplying water to 30 acres of agriculture land at the farm has failed. The system mainlines and lateral lines are decades old and multiple attempts to repair the system over the years have only proven to be temporary and have become very cost prohibitive. A new irrigation system will provide the farm with decades of reliable irrigation water, be far more efficient to manage and will provide a significant savings in annual water usage. Several farm user groups rely heavily on irrigation during the growing season. Blom and Olson said they wanted more information before they moved forward on the amendment. **Motion died due to lack of a second motion.**

**ACTION:** Moved by Olson to **APPROVE** Resolution 2017-05-11 as amended. Blom seconded the motion. Chair Marc Boldt and Councilors Stewart, Olson, and Blom voted aye. Motion carried.

**PUBLIC HEARING: DISTRICT COURT FEES**

To consider a proposed increase to Work Program sign-up fees and Victim Panel fees assessed by District Court against offenders that participate in the programs, along with modifying the credits earnable by offenders toward legal obligations for work done in the Work Crew Program.

Lisa Biffle, District Court / Corrections and Bill Richardson, Prosecuting Attorney's Office presented. Further discussion ensued.

**ACTION:** Moved by Blom to **APPROVE** Resolution 2017-05-12. Olson seconded the motion. Chair Marc Boldt and Councilors Stewart, Olson, and Blom voted aye. Motion carried.

Blom spoke about upcoming discussion regarding the Interim County Manager and selection of the new C-Tran CEO.


