REQUESTED ACTION:

Approval from the Board of County Councilors for the cancellation of delinquent property taxes, assessments and fees for real, business personal and mobile home property accounts submitted as uncollectable.

X Consent Hearing County Manager

BACKGROUND

Pursuant to RCW 84.56.240, the County Treasurer shall submit a list of uncollectable taxes to the Board of County Councilors by the first day of February each year.

The Treasurer's Office has performed due diligence and inquiry upon delinquent tax accounts as provided within the attached submission and as such, recommends \$303,685.38 in taxes, assessments and fees be approved by the Board as uncollectable. Of the amount submitted, approximately 22.4% or \$68,079 is attributed to County funds (General Fund, Road Fund, etc.) The remaining amount of \$235,606 represents uncollectable revenues for taxing and special assessment districts within Clark County.

The Treasurer's Office has specific statutory remedies for the collection of delinquent property taxes. For Real Property, the Treasurer is required to foreclose on properties with taxes that have become three years past due. For Personal Property, which includes Mobile Homes and Business Personal Property, the Treasurer can distrain (seize) and liquidate business assets for payment of the taxes once the accounts have become delinquent.

Despite these remedies, situations exist in which the Treasurer does not have viable collection solutions beyond statutory remedies. After a thorough review of delinquent accounts and working with the Prosecuting Attorney's office to explore other proposed remedies, we have conceded that the accounts in the attached listing should be submitted as uncollectable as there are no structures to foreclose upon, no assets to distrain, no real property in which to attach a lien, or the taxes billed were due to manifest errors. In some instances, the cost to collect exceeds the value of collection attempts.

As such, the Treasurer's Office requests that these delinquent accounts be approved by the Board of County Councilors as uncollectable. Once these accounts become a full four years delinquent they will be submitted to the Courts to permanently extinguish them from the County's tax rolls per RCW 84.56.270.
