#### BACKGROUND

For the last several years, Clark County Public Health (CCPH) has contracted with the Office of Superintendent and Public Instruction (OSPI) to conduct inspections of sites preparing and serving food to kids through a summer lunch program. The summer lunch program serves a critical need within Clark County better ensuring children have access to healthy food that might otherwise go hungry. CCPH partners with OSPI to ensure those preparing and serving food do so in a sanitary manner to prevent foodborne illness. It is anticipated that CCPH staff will conduct 23 inspections and compensation amounting \$243.00 per inspection to cover staffing costs.
