BACKGROUND

To be in compliance with RCW 36.77.070, Clark County must publish annual notices regarding the use of county forces on Public Works projects.

Board approval will authorize publication of both notices for 2016 and 2017 county forces work.

ADMINISTRATIVE POLICY IMPLICATIONS

COMMUNITY OUTREACH

Outreach for the 2017-2022 Transportation Improvement Program included two work sessions and a hearing with the Board of County Councilors and presentations to Clark County Planning Commission, Development and Engineering Advisory Board and Clark County Finance Committee, as well as outreach and information on the county website. A SEPA review was also included in the Capital Facilities Plan approval process.







- Preparatory work, crack filling, signing, striping and/or placement of shoulder rock incidental to 2017 HMA Overlays at various locations including: NE Highway 99 (Railroad bridge to NE 78th St.), NE 99th St. (Highway 99 to St. Johns Rd.), NE Padden Parkway (78th St. to NE Andresen Rd.), NE 184th St. (NE 182nd Ave. to NE 198th Ave.), NE 68th St. (Highway 99 to City Limits), NE 72nd Street (Highway 99 to NE 16th Ave.), NE 299th St. (Lewisville Hwy. to NE 82nd Ave.), NE 16th Ave. (NE 72nd St. to NE 78th St.) and NE 179th St. (NW 11th Ave. to NE Delfel Rd. South).

The Clark County Engineer estimates the construction costs for these projects will be **\$ 235,000.**
