#### BACKGROUND

The Camas City Council approved Ordinance No. 15-030 on December 21, 2015, annexing the Grand Ridge subdivision, pursuant to the Island annexation method established in RCW Chapter 35A.14.

Two parcels owned by Clark County Public Works were included in the annexation, but ownership was never formally transferred to Camas. Parcels 125606-116 and 125662-194 are known as Grand Ridge Phase 2 Tract B and Grand Ridge Phase 4 Tract A. Both parcels contain stormwater treatment and flow control facilities.


Maintenance responsibility for the stormwater facilities was transferred to the City of Camas on the annexation's effective date.

The requested action finalizes the intended transfer of tract ownership to the City of Camas.
