**Councilor Reports**

**Veteran's issues**

Stewart spoke about her one on one meetings with the City Council members and spoke about setting up a meeting with Royce Pollard to discuss Veteran's issues. She stated she would be talking with the Clark County Veteran's Board who oversees the Clark County Veteran's Assistance Fund.

**Letter pertaining to Oregon tolls**

Quiring presented a letter conveying their concerns about the potential tolling of the Interstate Bridge, Glenn L. Jackson Bridge, and Interstate 5 and Interstate 205 between the Washington border and the instates convergence near Wilsonville. Further discussion ensued about Congresswoman's Jaime Herrera Beutler recent transportation amendment / bill. Chris Horne, Deputy Prosecuting Attorney, joined the discussion. Further discussion ensued.

**Rail Bill**

Quiring updated the Board on the specifics of the bill. Further discussion ensued about moving forward on code language. Further discussion ensued about the urban growth boundary.

**Whipple Creek**

Blom spoke about a trail improvement / access project and future developments. Further discussion ensued. Horne joined the discussion. Further discussion ensued about healthier living. 
**Washington State Association of Counties (WSAC)**


***The Board adjourned Board Time at 2:11 p.m. and convened in executive session regarding pending litigation that will last about 1 hour.***


