Background

- Per RCW36.70A.470(2) Each county and city planning under RCW 36.70A.040 shall include in its development regulations a procedure for any interested person, including applicants, citizens, hearings examiners, and staff of other agencies, to suggest plan or development regulation amendments. The suggested amendments shall be docketed and considered on at least an annual basis, consistent with the provisions of 36.70A.130.
- CCC40.560.030 Amendments Docket This section is enacted pursuant to RCW 36.70A.470. This process is allowed per County and State Statute.

Method of Review

- Suggested plan or development regulation amendments may be submitted in writing in to the responsible official.
- Any plan map changes initiated through this section shall be processed in accordance with Section 40.560.010 and relevant county code and plan provisions.
- Requests for map or text amendments to the comprehensive plan or implementing development regulations received by the county prior to September 1st will be considered in conjunction with the adoption of following year's work program.





Plan Map Amendment –Cornerstone Mixed Use (MX) to UL (R1-6)




Plan Map Amendment –Wollam


Commercial (NC) to UL (R1-6)




Plan Map Amendment –Ward/162nd Commercial (GC) to UH (R-30)

 - The atlas depicts the long range regional roadway system plan needed to support the land use plan and help fulfill the transportation objectives of the comprehensive plan.


Arterial Atlas – Fairgrounds Circulation
