To consider the 2017-18 Budget Mid-Biennium Review and Modification amending the 2017-2018 biennial budget. The property tax levies for 2018 will also be considered at this time for the General Fund, Road Fund, and Conservation Futures fund.

Jim Rumpeltes, Interim County Manager, presented the executive summary.

Adriana Prata, Budget Director, presented.

**ACTION:** Moved by Blom to **APPROVE** a 0% increase to the Road Fund Levy, Resolution 2017-12-05. Olson seconded the motion. Councilors Boldt, Stewart, Olson, Blom and Quiring voted aye. Motion carried.

**ACTION:** Moved by Olson to **APPROVE** a 0% increase to the Conservation Futures Levy, Resolution 2017-12-06. Blom seconded the motion. Councilors Boldt, Stewart, Olson, Blom and Quiring voted aye. Motion carried.

**ACTION:** Moved by Blom to direct the County Manager to create a levy certification amount increasing in accordance with the increase to the General Fund. Olson seconded the motion. Councilors Boldt, Stewart, Olson, Blom and Quiring voted aye. Motion carried.

**ACTION:** Moved by Olson to **APPROVE** the 2017-18 Budget Readopt 2017-12-03. Blom seconded the motion. Councilors Boldt, Stewart, Olson, and Blom voted aye. Councilor Quiring voted nay. Motion carried.
