against the County in the amount of \$3,722,648.37 .



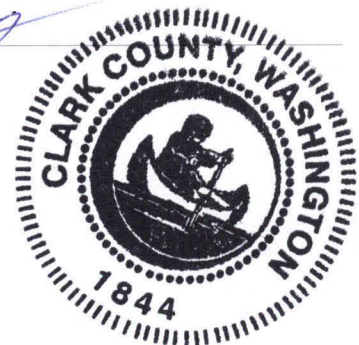
