REQUESTED ACTION: To approve the reallocation of jail duct cleaning funding for 2017-18 to cover new correction center chiller compressors, juvenile duct cleaning and jail work center duct cleaning.

BACKGROUND

In December of 2015 the BOCC approved a package to cover the cleaning and repair of the correction center air ducts and awarded \$450,000 to cover the cost for 2015-2019. We would like to repurpose the 2017-18 portion of this fund which is \$100,000 for the replacement of 4 of 12 chiller compressors in the corrections center which have recently stopped working and to complete air duct cleaning at the juvenile center and the jail work center. Better Air Northwest who was awarded the contract to complete cleaning at the corrections center and other county facilities will continue to do the work at the Jail Work Center and Juvenile Center. Facilities has obtained three quotes to replace the four Correction Center Chiller Compressors which are estimated to cost \$20,000. Facilities was able to complete repairs and cleaning of the jail with-in the funding allotted for 2015-16 and will go back in 2019 to do a routine cleaning with the remaining funding.
