In response to requirements of the National Pollutant Discharge Elimination System Permit and ongoing community outreach needs associated with the 2015 Stormwater Manual, Clean Water needed to hire a dedicated Environmental Outreach Specialist.

In May 2017, managers met to discuss how this shared position was working. Participants agreed that Solid Waste was not efficiently using this position and Clean Water had a clear need for additional outreach support. Accordingly, participants agreed it was best to convert this shared position to a full-time position in Clean Water, as of June 1, 2017.
