BACKGROUND

This project will apply a friction treatment on the four roadways listed below to reduce vehicle crashes at four locations where severe and/or fatal crashes have occurred.

- NE Risto Road (west of NE 223rd Court)
- NE Lucia Falls Road (west of NE Sunset Falls Road, at Moulton Falls Regional Park)
- NE Gabriel Road (east of NE 171st Court)
- NE Washougal River Road (west of NE Hughes Road)

Curve warning signage also will be installed at the NE Lucia Falls Road location.

For the safety of workers and drivers, this project will temporarily close portions of one travel lane during construction.

COUNCIL POLICY IMPLICATIONS

None. This project supports the county council's policy of investing in the county road system by providing a safe and efficient transportation system.

ADMINISTRATIVE POLICY IMPLICATIONS

None. The project is included in the 2017-2022 Transportation Improvement Program, 2017 Annual Construction Program (Item No. 20), and 2017-2018 budget.

COMMUNITY OUTREACH

Outreach for the 2017-2022 Transportation Improvement Program included two work sessions and a hearing with the county council and presentations to Clark County Planning Commission, Development and Engineering Advisory Board and Clark County Finance Committee, as well as neighborhood outreach and information on the county website. A SEPA review was also included in the Capital Facilities Plan approval process.

Prior to the start of construction, Public Works will issue a news release and disseminate information through social media.


