# BACKGROUND

On July 25, 2017, the Board of County Councilors approved an interlocal agreement between Clark County and the city of Vancouver for the Van Mall North Annexation (SR 159-17). This request is to execute the quit claim deed to transfer land for Kelley Meadows Neighborhood Park (tax parcel numbers 105522-616 and 105240-000), a wetland mitigation site (tax parcel number 156194-000) and the pedestrian path to Walnut Grove Elementary School (tax parcel number 106361-288). All of these parcels are now within the city limits.


