BACKGROUND

The 2018 Preservation ADA Ramp Improvements projects will construct or upgrade sidewalk curb ramps to meet current Americans with Disabilities Act regulations prior to pavement preservation work. This annual work is bid in multiple groups due to the large number of locations involved.

For the safety of workers and the traveling public, Clark County may close portions of one travel lane periodically during construction, which is scheduled through spring 2018.

The first group (Group 1) of ramps was approved for advertisement on September 19, 2017. Groups 2 and 3 are ready for construction at the following locations:

Group 2: 15 new ramps at 7 intersections:

- NE Hazel Dell Avenue: NE 105th Street to NE 106th Street
- NE 6th Avenue: NE 106th Street and NE 111th Street
- NE 105th Street: west of NE 9th Avenue and NE Stutz Road
- NE 112th Street: NE 5th Avenue to NE 10th Avenue

Group 3: 72 new ramps at 40 intersections:

- NW 9th Avenue at NW 91st Street and NW 92nd Street
- NW 17th Avenue, from south of NW 90th Street to NW 93rd Circle
- NW 20th Avenue south of NW 92nd Street
- NW 26th Avenue, north of NW 104th Street to NW 115th Street
- NW 28th Avenue north of NW 113th Street
- NW 29th Avenue, NW 112th Street to NW 113th Street
- NE 41st Avenue at NE 97th Street and NE 98th Street
- NW 88th Street, from NW 21st Avenue to NW 15th Avenue
- NW 90th Street at NW 19th Court
- NW 91st Circle east of NW 17th Avenue
- NW 94th Street, NW 15th Avenue to NW 25th Avenue, and NW Westgate Drive
- NW 108th Street, west of NW 26th Avenue and NW 29th Avenue
- NW 109th Street, NW Lakeshore Avenue to NW 29th Avenue
- NW 99th Street at NW 24th Avenue (Detectable Warning Plates)
- NW 113th Street at NW Lakeshore Drive (Detectable Warning Plates)

Construction documents are complete. Board approval of the attached Notice to Contractors is needed to authorize bid advertisement of this project.

COUNCIL POLICY IMPLICATIONS

None. This project supports the council's policy of investing in the county road system by providing a safe and efficient transportation system for all county residents.

None. The project is included in the Adopted 2017-2022 Transportation Improvement Program (TIP), 2017 Annual Construction Program (Item No. 19), and 2017-2018 budget.

COMMUNITY OUTREACH

The 2017-2022 TIP community outreach process included two work sessions and a hearing with the Board of County Councilors, presentations to Clark County Planning Commission, Development and Engineering Advisory Board and Clark County Finance Committee, as well as neighborhood outreach and information on the county website. A SEPA review was also included in the Capital Facilities Plan approval process.

Public Works has developed a one-page handout explaining why the county builds or reconstructs disabled-accessible sidewalk ramps on street corners prior to some preservation projects. That handout is posted on the county's website and will be used in community notification and outreach as needed.

Sealed bids shall be delivered to the office of Clark County Purchasing, Public Service Center, 1300 Franklin Street, Suite 650, Vancouver, Washington 98660 (or P.O. Box 5000, Vancouver, WA 98666-5000). Bids delivered to locations other than as indicated above or received after the time indicated above will not be accepted. Bids will be publicly opened and read aloud at 2:00 P.M., or as soon thereafter as possible, on the same day in the Hearing Room of the Board of County Councilors, 6th Floor of the Public Service Center.

Description of work: Improve sidewalks and ADA ramps, including curb and pavement restoration, at various locations in Clark County.




