BACKGROUND

The Transportation Improvement Program identifies prioritized transportation projects and proposed funding for design, property acquisition and construction during the next six years.

Each year, Clark County must prepare a six-year TIP to comply with RCW 36.81.121. RCW 36.81.130 requires the county adopt an Annual Construction Program that includes all capital road projects. In addition, WAC 136-16-030 requires the Annual Construction Program include all road equipment purchases for the year. The 2018 Annual Construction Program details implementation of the first year of the six-year TIP.

The Public Works Director and Programming staff held a work session with the Board of County Councilors on June 21, 2017, to confirm upcoming priority transportation projects. The Public Works Director/County Engineer has reviewed the recommended program.

A hearing for the BOCC's consideration and adoption of the recommended 2018-2023 Transportation Improvement Program and the 2018 Annual Construction Program is scheduled for 10 a.m. Tuesday, Oct. 31, 2017.

COUNCIL POLICY IMPLICATIONS

None. These programs must be adopted annually before county budget adoption and must include projects and their relative priorities. Once the BOCC adopts the Annual Construction Program, a unanimous vote is needed to revise it. WAC 136-16-042 states the adopted annual program may not be changed, revised or increased except by unanimous vote of the members of the legislative authority who are present when the vote is taken. Such modifications shall be by resolution of the legislative authority and shall list each changed, revised or added project. A copy of such resolution shall be forwarded to the county road administration board within thirty-days of its adoption.

ADMINISTRATIVE POLICY IMPLICATIONS

None. The 2018-2023 Transportation Improvement Program is constrained by forecasted revenues. The BOCC has discretion to borrow or bond to accelerate transportation projects, in which case Public Works will incorporate changes in the future TIP. The proposed six-year TIP is consistent with the 20-Year Capital Facilities Plan. The BOCC has discretion to amend the 2018 Annual Construction Program throughout the year by unanimous vote.

COMMUNITY OUTREACH

The development of the 2018-2023 Transportation Improvement Program included a BOCC work session, presentations to the Clark County Planning Commission, the Development and Engineering

Advisory Board and the Regional Transportation Advisory Committee. A SEPA review provided an additional opportunity for public comment. A public hearing before the BOCC is the final step in public involvement for TIP adoption.
