BACKGROUND

Transmitted for acceptance by the Councilors is the plat for Fishwood Subdivision PLD2009-00032/FLD2017-00030

Project review: The application vested on March 6, 2009. A pre-application conference was held April 2, 2009. Preliminary approval was issued on October 26, 2009. Final engineering approval was granted November 16, 2016.

Zoning: R1-6; **Lot Size:** The R1-6 zone has a minimum average lot area of 6,000 square feet and a maximum average lot area of 8,500 square feet. **Actual Lot Size:** Parcels range in size from 4,883 square feet to 8,486 square feet.


The lots are below the standard minimum average lot size of the zone because a significant portion of the site is encumbered with habitat and wetlands, therefore the applicant utilized the density transfer provisions of the code (40.220.010.C.5). Density transfer allows the lots that would have been placed within the environmentally sensitive area to be placed on the developable portion of the site. This results in the preservation of the resource areas with overall smaller lot sizes. The proposed lots that abut other single family zoned parcels must meet specified minimum size standards.

COMMUNITY OUTREACH

The proposed land division went through the standard land use review and approval process. Notice of application was mailed to the applicant, the neighborhood association and property owners located within 300 feet of the site on August 17, 2009. One notice of the application and hearing were posted on the site and two within the vicinity on September 23, 2009.



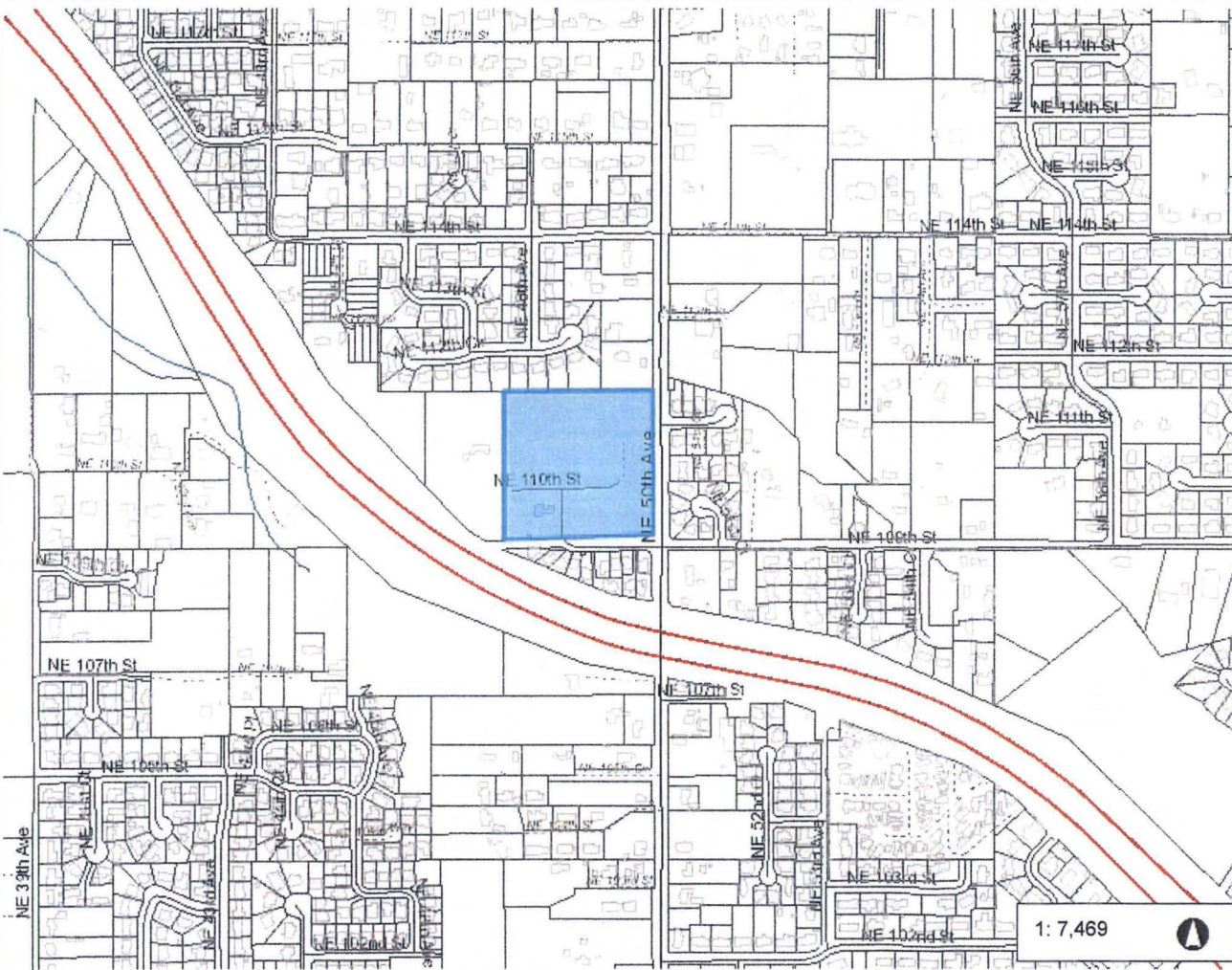
