

## NOTICE OF PUBLIC HEARING

The Clark County Council will hold a public hearing at **6pm, Tuesday, July 16, 2019**, in the Councilors Hearing Room, sixth floor, Public Service Center, 1300 Franklin St., Vancouver, Wash. to consider the following:

1. Selecting a financing option to reasonably fund the localized critical links and intersection improvements to remove urban holding and maintain concurrency in the I-5/NE 179<sup>th</sup> Street area;
2. CPZ2018-00021 Holt Homes – To consider the recommendation of the Planning Commission to remove the urban holding zoning and comprehensive plan overlays on approximately 143 acres designated in the Comprehensive Plan and zoning map upon a determination by Council that critical links and infrastructure improvements are reasonably funded.


