RESOLUTION NO. 2019-2020-013**

Rescinding Portions of Resolution 2019-2020-010 and Postponing Bond Proposition

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF RIDGEFIELD SCHOOL DISTRICT NO. 122, CLARK COUNTY, WASHINGTON, as follows:

WHEREAS, Ridgefield School District No. 122, Clark County, Washington (the "District"), is a first-class school district duly organized and existing under and by virtue of the Constitution and the laws of the State of Washington;

WHEREAS, on February 25, 2020, the Board of Directors of the District (the "Board") adopted Resolution 2019-2020-010 authorizing the submission of Proposition No. 1 for the issuance of unlimited tax general obligation bonds, to the voters of the District at a special election to be held on April 28, 2020;

WHEREAS, on February 29, 2020, Washington State Governor Jay Inslee declared a state of emergency in all counties of our state under Chapters 38.08, 38.52 and 43.06 RCW, and directed implementation of the plans and procedures of the state's Comprehensive Emergency Management Plan in response to the novel coronavirus (COVID-19);

WHEREAS, on March 11, 2020, the World Health Organization characterized COVID-19 as a pandemic;

WHEREAS, on March 13, 2020, the U.S. President declared a national state of emergency and Governor Inslee ordered closure of all public and private K-12 schools in Washington State until April 24, 2020, to contain the spread of COVID-19;

WHEREAS, the Secretary of State of Washington and county election officials across the state have requested that the Governor of the State of Washington use his emergency authority to cancel the State's April Special Election due to concerns surrounding COVID-19; and

NOW, THEREFORE BE IT RESOLVED, by the Board of Directors of Ridgefield School District No. 122, Clark County, Washington, as follows:

1. The Board hereby rescinds those provisions of Resolution 2019-2020-010 related to submission of Proposition No. 1 to the voters of the District at the April 28, 2020 Special Election, and postpones the submission of Proposition 1 to the August 4, 2020 Primary Election.
2. The Board hereby delegates to the Secretary of the Board the authority to take all actions necessary to submit Proposition No. 1 to the Clark County Auditor as *ex officio* supervisor of elections in Clark County, Washington for the August 4, 2020 Primary Election.
3. All other provisions of Resolution 2019-2020-010 are hereby ratified.

This resolution shall become effective immediately upon its adoption.
