RE: Updated CDC guidance related to Ebola Virus Disease (EVD)

Please be advised that due to rapidly evolving circumstances concerning the Ebola outbreak in West Africa, the Centers for Disease Control and Prevention (CDC) is updating its website on a daily basis, including new guidelines and tools for providers.

Although the CDC says Ebola does not pose a significant risk to the U.S. public, we encourage all providers to monitor the CDC's website regularly for the latest information. http://www.cdc.gov/vhf/ebola/outbreaks/guinea/index.html.

As of August 28, the number of suspect and confirmed cases in West Africa now stands at more than 3,000; the actual number of cases could be many thousands more.
