My concern is this: Kittelson was not contracted to update the Traffic Management plan until after our January 11 monthly meeting (as per the county update). So the draft will not be available until the week of March 19 (again, as per the county update).

That is only 47 days until the first event. What if, as I fear, it fails to adequately address all the traffic problems? That is a likely outcome because there is no plan for public input. And, we still have no response to our questions about the scope of the project.

Hello Bridget,

This month's update is less formal and unfortunately, briefer than my February 1st update. FYI, both of my indigent defense employees left employment within a span of nine days – both unexpectedly. I've been in triage-mode.

- 1. I last informed you that the Amphitheater operator anticipated a Kittleson draft update of the Traffic Management Plan and the Early Start Matrix to be prepared by mid-February. The current estimate is that the drafts will be completed by the week of March 19.
- 2. Early start times have been approved by WSDOT and Clark County for the Rod Stewart and Chris Stapleton events.
- 3. We continue internal meetings and meetings with the operator to ensure the 2018 season is safe, compliant and successful for everyone. Planning for the pre-season social event continues.
