WHAT WE'VE BEEN UP TO THIS MONTH:

- Rick and Mary met with Jose and Oliver from Community Planning, see below for the highlights.
- We've recently connected with our neighbors, Meadow Glade Neighborhood Association. They too are affected by the FRDU and we plan conducting joint meetings with them.
- We will be meeting with the county councilors in April.
- We attended the State of the County Meeting. If you're interested in the highlights, please let us know and we'll gladly send you a recap.
- We hope to have electronic financial records by this summer.

Highlights from meeting with Community Planning

- Oliver explained that after legislation passed, the county could've chosen to do nothing. Instead, they told Oliver and his team to move forward.
- The process was controlled by the old council. Planning Dept. felt uneasy when they were told to fast track it through.
- If process is picked up by the council, they'll recommend a work session.
- There are concerns regarding the legislation and how it will be implemented.
- Currently there isn't an entity to guide growth in rural areas
- Both Jose and Oliver want to have a productive relationship moving forward to support our community.
- Lack of awareness as to what the FRDU looks like from a legislative perspective and how it's implemented by the county.
- RR Advisory Board is focused on economic development through the Railroad.
- Initially, planning didn't know about the bill and it was vetoed; however, Senator Wilson pushed it through.
- The council rejected Friends of Clark County, Parks and other NA's to form a subcommittee.
- There hasn't been any recent conversation about the FRDU.
- The railroad made a recommendation to extend the map to 1 mile.

Facts About GBPNA:


- Established in 1999
