Put a first class stamp (\$0.47) on the envelope and mail it on or before election day, Tuesday, August 2. Your ballot must be postmarked no later than election day, so check the pick-up schedule on the mail box or confirm election day hours with the post office.

If you return your ballot to a drop site location, it must be returned by 8:00 PM on Tuesday, August 2, for it to be counted.
