Relocation / Prevent Relocation / Change of Venue / Qdro / Revision / Trial – Assigned Judge

Settlement conference is scheduled – case still has to be on Commissioners docket.

If the case has settled – scheduled with the Judge/Commissioner who settled the case.

If not settled – schedule with assigned Judge.

To determine the right docket:

1 – is the case # (before or after 2006)

2 – search for attorney (if more than 6 months since last activity by attorney we assume it's a case w/o atty)

3 – without an attorney – Wednesday @ 1:30pm – w/ the exception of agreed or default orders (those should be scheduled on Friday @ 1:30pm)

4 –with an attorney – without final orders – Wednesday @ 9am / with final order – Thursday @ 1:30pm
