To consider a proposed ordinance to authorize use of wheeled all-terrain vehicles (WATVs) on county roads with a posted speed limit of 35 mph or less.

**ACTION:** Moved by Councilor Medvigy to **CONTINUE** the hearing to a date uncertain to give staff additional time to work on the ordinance and allow for more public comment. Councilor Quiring O'Brien seconded the motion. Councilors Medvigy and Quiring O'Brien voted aye. Councilors Blom and Lentz voted nay. Motion failed.

Councilor Lentz seconded the motion. All aye/motion carried.
