REGISTRATION

- An annual twenty dollar (\$20.00) fee is required for the registration of all alarm systems.
- Alarms must be registered with the Clark County Sheriff's Office **before** activation.
- If reason exists to believe an alarm system is not being used, or maintained in a proper manner an inspection may be required. Inspections and corrective action shall be the responsibility of the alarm user, or alarm service company.

VERIFICATION

A penalty of one-hundred dollars (\$100.00) may be issued to any alarm monitoring company that fails to attempt verification of alarm system activation. Methods of verification include:

- The establishment of voice communication with an authorized person near the alarm site.
- An electronic means for the alarm user to notify the monitoring company to cancel an alarm.
- The installation of a video system that allows the monitoring company the ability to ascertain that activity exists warranting a police response.
- A system of confirmation of the need for a public safety response before an alarm dispatch request to the County.
- An alternate system approved by the Clark County Sheriff.

PENALTIES

The revised code also includes the following penalty structure:

• Failure to register	\$100 and possible disconnection
• 1 st false alarm in a twelve month period	\$50
• 2 nd false alarm in a twelve month period	\$100
• 3 rd false alarm in a twelve month period	\$150
• 4 th false alarm in a twelve month period	\$200
• 5 th false alarm in a twelve month period	\$250
• 6 th false alarm in a twelve month period	\$300 and possible deactivation
