

# Challenge to Voter Registration

how to challenge a voter registration in Washington state

---

## general information

Registration of a person as a voter is presumptive evidence of his or her right to vote. However, the registration of a voter may be challenged by another registered voter.

The challenge process is established in RCW 29A.08.810 through RCW 29A.08.850.

A challenge may be dismissed if it is not in proper form or based on any other reason than those described in statute 29A.08.810.

## residency requirements

Residency requirements, as defined in Article VI, section 4 of the Washington State Constitution and RCW 29A.04.151, and 29A.08.112 may not be challenged if the voter is:

- absent while in service of the state or federal government
- attending school
- confined in a public prison
- at sea
- lacking a traditional residential address such as a shelter, park, motor home or marina.

## filing a challenge

Only a registered voter or the county prosecuting attorney may file a challenge to a voter's registration. A challenge must be based on the challenger's personal knowledge.

The completed challenge form, with supporting documentation, is submitted to the county elections office of the county where the challenged voter is registered to vote.

## challenging a ballot

In order to affect the validity of a ballot, challenges must be filed at least 45 days before the election.

If the challenged voter registered or moved less than 60 days before the election, a challenge must be filed at least 10 days before the election or 10 days after the voter registered, whichever is later.

## challenge process

Upon receipt of the challenge the County Auditor or the county elections officer will:

- review the form for completeness and factual basis
- notify the challenged voter and interested parties of the challenge
- post the challenge documents on the Auditor's web site
- set a hearing time and date

Either the County Auditor or County Canvassing Board will conduct the hearing, depending on the date of the challenge filing. Testimony by affidavit or in person must present clear and convincing evidence that the voter's registration is improper. Final determination of the challenge may be appealed in Superior Court.

## public information

All challenge documents are public records. Challenge documents will be posted on the County Auditor's website.

# Washington House candidate's Battle Ground rental raises eligibility questions

**Republican John Ley said he's renting a room at a friend's house in order to run for the open district seat there.**

Here's a question that couchsurfers and Clark County's auditor have in common: How many nights have to pass before a person should be considered "living" someplace? The auditor will try to answer that question very soon.

On Thursday, state representative candidate John Ley became the subject of an official challenge that contends he doesn't actually live in the district he's trying to represent, Washington's 18th legislative district.

Vancouver resident Carolyn Crain wrote in the challenge that Ley's real home is a two-



Clark County Auditor Greg Kimsey confirmed to OPB that a hearing will have to be held. The quasi-judicial process will determine whether or not a living arrangement Ley struck with a family friend qualifies his campaign.

The challenge comes as 10 candidates, Ley included, are jockeying for three open legislative seats in Southwest Washington.

Reached by phone on Friday, Ley confirmed he doesn't live in the Battle Ground-area home he listed on his voter registration. The home belongs to family friends, he said, to whom he is paying rent for a room.

"As far as I know, everything I did is acceptable according to current law," Ley said. "As I interpreted them, I could rent a room up there and legally change my voting address if I wanted to."

The 18th District seat is especially enticing, Ley said, because of a chance to be a decision-maker on replacing the Interstate 5 Bridge. Had Ley campaigned in his district, which also has an open seat, he said it was less likely he could land on the bi-state legislative committee.

The estimated \$5 billion project is expected to be one of the largest infrastructure projects in the region's history. Ley has been a vocal critic of many aspects of the proposal, especially tolling plans.

"It's a huge waste of taxpayer money," Ley said. "I looked at the landscape and said,

Ley declined to elaborate on the rental agreement he struck with his friends, whom he said are snowbirds that split time between Washington and Arizona. Ley said he couldn't recall the last time he spent a night there.

"I don't know off the top of my head," Ley said when asked if he had slept there within the last month.

Washington law requires would-be candidates to be eligible voters for the office they seek. Registering to vote at a new address requires only that a person has lived at the address for 30 days prior to the next election.

Crain, a fellow Republican and a local precinct committee officer, said she was motivated to challenge because of what she described as a dedication to America's "core structure" of a representative Republic.

"I don't care what the political party is, whether it's my party or a different party, I believe the only way we're going to pull our country back together is to uphold our core principles and our foundation and our Constitutional protections," Crain said.

This isn't the first time Crain has challenged candidates. In 2017, she led the residence challenge of then-Port of Vancouver commission candidate Don Orange, who owned a home outside the port district but rented an apartment within the boundaries when he filed. Orange later won the seat.

"The law has weird quirks and loopholes in it which will make some of these challenges difficult to prove," said Crain, who lives in the 49th District in western Vancouver. "I do think I can win. And I think it's important that voters start focusing on who is representing them and what their actual level of integrity will be."

Ley said he is not breaking any rules and is prepared for a formal hearing.

## Registration challenge claims John Ley not eligible to run for 18th District Updated 3 hours ago


Ley listed as owner of Camas home, registered to vote with Battle Ground address

Campaign season for the 2022 election is barely underway, but the Clark County Auditor's Office has already received a challenge to one candidate's bid for office.

Vancouver resident Carolyn Crain claims Republican John Ley isn't eligible to run for the 18th Legislative District Position 2 seat in the state House of Representatives because he doesn't live in the district.

According to a voter registration challenge filed by Crain, Ley resides in Camas and not at the Battle Ground address listed on his voter registration.

County property records list Philip and Eileen Haggerty as the owners of the Battle Ground address Ley provided. However, Ley is listed as the owner of a Fremont Street home in Camas.

In her challenge, Crain confirmed she had sent a letter with "return service requested" to all of Ley's known addresses, had searched local phone directories and county property records, searched the statewide voter registration database and visited the voter's residential address.

County Auditor Greg Kimsey said he will hold a hearing with Ley and Crain on June 10 where Ley can "provide evidence that he does reside at the address in his voter registration record."

"After that hearing, I will decide if her allegation is correct or if it is not correct," Kimsey said. "My decision may be appealed to a Superior Court Judge."

Kimsey said this is only the third voter registration challenge to have a hearing in the nearly 24 years he's been the county auditor.

Republicans Greg Cheney and Brad Benton are also running for the 18th District seat, along with Democrat Duncan Camacho.

The city of Camas had previously been within the 18th District boundary but that changed after the state legislature completed its redistricting process earlier this year. Camas now lies within the 17th Legislative District.

Although two lawsuits by groups out of Central Washington are still pending, U.S. District Judge Robert Lasnik signed an order in April allowing the new state maps to be used for the 2022 election cycle.

Crain previously filed a complaint against Ley with the Public Disclosure Commission in 2020 claiming he failed to submit contribution and expenditure reports on time and also failed to properly break down and describe expenditure details.

“Based on these findings, the staff issued a formal written warning to Mr. Ley regarding the failure to timely and accurately report ... and failure to properly break down and describe expenditure details,” as required by state law, the PDC website states.

Neither Ley nor Crain returned calls for comment.

You must be a U.S. citizen to apply for a Washington enhanced driver license (EDL) or enhanced ID card (EID).

Show us **all** the following documents:

- [Proof of every time your name has changed since birth, if applicable](#)
- [Proof of Social Security number](#)
- [Proof of Washington State residence](#)
- [Additional requirements for teens and children](#)

Acceptable **documents must be original** or government-certified copies, unless noted otherwise. Get a [checklist](#) to help you prepare.

We **don't accept** documents that are:

- Photocopies
- Printouts from websites
- Temporary
- Uncertified
- Notarized
- Altered

## Proof of U.S. citizenship

Show us **1** of the following:

- Valid [U.S. passport](#) *book or card (travel.state.gov)*
- [U.S. Certificate of naturalization](#) (*uscis.gov*)
- [U.S. Certificate of U.S. citizenship](#) (*travel.state.gov*)
- [U.S. Department of State consular report of birth abroad](#) (*travel.state.gov*)
- Original, certified [birth certificate](#) from your [U.S. birth place](#), issued by a city, county, state, or territory (Puerto Rico, Guam, U.S. Virgin Islands, or Commonwealth of the Northern Mariana Islands) and have all the following:
  - Full name and date of birth
  - Place of birth (state with county or city; must be a U.S. location)
  - A registrar's raised, embossed, impressed, or multicolored seal
  - A control or file number that the issuing authority can confirm
  - A registrar's signature
  - The date the certificate was filed with the registrar's office
  - Only Birth Certificates from Puerto Rico issued on or after July 1, 2010 are accepted
  - **Washington wallet-sized birth registration cards aren't accepted**

## Proof of identity

Show us **1** of the following:

- **U.S. Passport book or card** - Valid and has your signature and photo
- **Driver license, enhanced driver license, enhanced ID, or state-issued ID card** - Valid and has your signature and photo
- **U.S. Military ID** - Valid and has your photo
- **Government employee ID** - Valid city, federal, or state ID card that has your signature and photo
- **Minors without the above** - See [Teens and Children](#)

## Proof of name change

**Your EDL/EID must be issued with the full legal name as it appears on the citizenship document unless accompanied with proof of name changes**

If the names on your proof of citizenship and proof of identity are different, provide document(s) for each time your name has changed.

- Court order showing your change of name
- Divorce decree (filed and certified by the court) showing the new name or authorizing a name change
- Marriage certificate (including same-sex marriage certificate) that has been filed with the county or authorized issuing authority and has the control or file number. Church or wedding chapel forms aren't acceptable. To get a certified copy of a marriage certificate, contact the:
  - County auditor where the license was filed
  - [Center for Health Statistics](#)

Example 1: You bring your birth certificate showing your birth name as Taylor Kelly Doe and your Washington driver license showing your current name as Taylor Kelly Johnson. You married twice and changed your last name from Doe to Smith, then to Johnson. You need to bring both of your marriage certificates to link your name from Doe to Johnson.

Example 2: You bring your U.S. passport and Washington driver license both showing your current name Taylor Kelly Johnson. You do not need proof of name change.

## Proof of Social Security number (SSN)

Show us **1** of the following documents showing the complete SSN. Partial SSNs aren't acceptable.

Note: The name on your EDL/EID application **must** match Social Security Administration records.

- Social Security Card
- W-2 Form with visible SSN
- SSA-1099 Form with visible SSN
- Non-SSA-1099 form with visible SSN
- Pay stub with visible SSN (internet printouts ok)

**If you change your name**, notify the Social Security Administration and wait to receive your new social security card **before** visiting our office.

**How your Social Security number is used**

It's used to help enforce child support laws. We'll verify the number with the Social Security Administration. It won't appear on your EDL/EID.

## **Proof of Washington State residence**

If you're applying for an Enhanced Washington driver license or identification card, you have to show 2 documents with your principal residence address.

- Acceptable documents must:
  - Show your current Washington residence address (unless noted below).
  - Show your first and last name.
- If you're married, you can use documents in your spouse's name. You'll need to show your marriage certificate.
- If you are under 26 years old you may use documents in your parent or guardian's name.
  - If you're under 18, see [Teens and Children](#) for additional requirements.
  - If you're 18 to 25, you'll need to show proof of relationship (e.g. birth certificate, adoption decree, court issued custody decree, etc.), but your parent or guardian doesn't need to be present.
- If you are 18 years old or over and are assigned a court guardian due to mental or physical limitations, you may use documents in your court assigned guardian's name.
  - You must show the court decree assigning guardianship.
  - Your assigned guardian must be with you and have valid proof of their identity.

Show us **2** of the following. You can't use 2 of the same document (e.g. 2 vehicle registrations), even if you're using documents under someone else's name.

- Previously issued WA license, ID card, or permit
  - This is not an option if you got a license in another state after your last WA license.
- Washington vehicle registration or title (a quick title isn't acceptable)
- Cell phone bill or statement \*
- Home utility or service document (bill, statement, hook-up order, etc.) for Washington address (gas, electric, water, garbage, sewer, landline phone, TV, internet, ISTA) \*
- Bank or credit card document (statement, card mailer, etc.) \*
- Washington voter card
- Washington school transcript or report card
- DSHS benefits letter (medical, food, etc.)

- Tribal ID
- Proof of home ownership (mortgage documents, property tax documents, deed, title, etc.) \*
- Selective Service Card
- Concealed weapons permit from a WA county (license to carry concealed pistol)
- Homeowner's or renter's insurance policy \*
- Auto insurance policy, declarations page, or binder \*
- Consulate ID card or Mexican Federal Electoral card
- Pay check or pay stub with the employer's name and phone number or address \*
- Washington professional license (nursing, physician, engineer, pilot, etc.)
- W-2 form from an employer or form 1099
- Moorage document
- Letter attesting residence in alternate housing (e.g. assisted living, college campus, mission, senior housing, shelter, or retirement home) on company letterhead with a phone number that could be used in verification of the facility
- US military document
- Certified Washington marriage certificate
- Form DS-2019

\* Items marked with an asterisk (\*) may be original or internet printouts.

## Teens and children

If you are under 18 years old, your parent or legal guardian must:

1. Come with you to the licensing office.
2. Sign the application.
3. Show us [proof of their identity](#).
4. Show us proof of their relationship to you with a:
  - Certified birth certificate.
  - Certified adoption document.
  - Court order naming the guardian and specifically authorizing the issuance of an EID.

If your parent or guardian's current name differs from the name on the proof of relationship document, bring proof of name change.

## Identification document review

If we can't accept your identification documents, you may request an additional document review by speaking with the driver licensing office ID Review Specialist. If the specialist is unable to determine positive identification, we may refer your documents for further evaluation.

## Photograph

Your card will include a photo showing a full front view of your face.

Before we take your photo, we'll ask you to remove anything that covers your face or head (like a hat or sunglasses) so your photo will be acceptable for biometric identification. If you choose not to remove it, you won't be eligible to receive an EDL/EID.




